### 1. Introduction

### 2. Information We Collect

#### 2.1 Personal Information

#### 2.2 Donor Information

We collect donor names, contact information, and donation amounts; payment information (processed securely); and communication preferences.

#### 2.3 Automatically Collected Information

We automatically collect IP addresses, browser type, and device information; website usage data and analytics; and data from cookies and similar tracking technologies.

#### 2.4 Third-Party Information

We may receive information from payment processors, banks, and financial institutions; social media profile information when you connect accounts; and public information related to grants and charitable activities.

### 3. How We Use Your Information

We use collected information to: provide and maintain Platform services; process donations and generate tax receipts; facilitate grant applications and reporting; ensure compliance with legal and regulatory requirements; communicate with users and donors; improve our services and user experience; and prevent fraud and maintain security.

### 4. Information Sharing and Disclosure

#### 4.1 Fiscal Sponsor

We share necessary information within Iglesia Del Evangelio Pleno De Miami Inc for fiscal sponsorship, compliance, and tax-exempt purposes.

#### 4.2 Service Providers

We may share information with trusted third-party service providers who assist in operating our Platform, including payment processors, email service providers, analytics providers, and customer support tools.

We implement appropriate technical and organizational measures to protect your information, including: encryption of sensitive data in transit and at rest; secure payment processing through PCI-compliant providers; regular security assessments and updates; and access controls and employee training.

### **7. Data Retention**

We retain personal information for as long as necessary to: provide services and support; comply with legal obligations; resolve disputes and enforce agreements; and maintain required records for tax and regulatory purposes.

### **8. Your Rights and Choices**

#### **8.1 Access and Correction**

You may request access to or correction of your personal information.

#### **8.2 Data Portability**

You may request a copy of your data in a portable format.

#### **8.3 Deletion**

You may request deletion of your personal information, subject to legal retention requirements.

#### **8.4 Communication Preferences**

You may opt out of marketing communications while still receiving transactional messages.

### **9. Cookies and Tracking**

We use cookies and similar technologies to: remember your preferences and settings; analyze website usage and performance; provide personalized content; and ensure security and prevent fraud. You can control cookie settings through your browser preferences.

## **11. Children's Privacy**

Our Platform is not intended for children under 18. We do not knowingly collect personal information from children under 18.

## **12. California Privacy Rights**
